

Pacific District (and Beenleigh Zone) Sports Representative Trials 2025

Dear Parents / Carers

The Pacific District (and Beenleigh Zone) will hold representative trials for all affiliated Queensland School Sports across the year, with the many held in Semester One. These trials are open to students who are at a level of skills and experience appropriate to compete at a representative level. It is the parent's and student's responsibility to be aware of the published due dates for each sport - the full range of Pacific District Representative Trials information for 2025 can be found on a separate attachment included in this communication. All students must nominate and complete the 'tasks' from the CHECKLIST below.

Please note the following:

- this nomination process is for CARBROOK JUNIOR SCHOOL STAGE 3 STUDENTS ONLY.
- nominations will need to be ratified by Mr. Linning (Carbrook PE Teacher and Sports Coordinator)
- these are 'one-off' trials that lead to further 'one-off' trials at Regional level... they are not a regular competition
- your age is determined by your year of birth... whatever you are turning this year is your age group

CHECKLIST:

- Complete the individual nomination/permission by the due date click <u>here</u> to access. Please note that only one sport per form, and that Swimming, Cross Country and Athletics/Track & Field will be selected through a separate nomination process, so a form is not needed for these.
- Complete the South Coast School Sport Permission/Medical Booklet click here to access the booklet. Please note that this booklet MUST be filled out electronically (it does auto-fill pages to save you time) – forms filled out with handwriting (apart from signatures) WILL NOT BE ACCEPTED.
- Booklet needs to be printed and then signed by Mr Linning and parents
- Booklet must be handed to trial convener by the student (Students without this booklet will not be permitted to trial).
- > Private transport arranged to attend the trials
 - VERY IMPORTANT (parents): if you are not taking your child but are having another parent/carer take your child to the trials, you must email the office giving your permission for your child to attend the trials with [name of person]... if this is not received, your child will not be permitted to sign out. That parent/carer will then take on the Duty of Care (supervision) of your child at the trials.

REMEMBER:

- > College sports uniform MUST be worn to the trials
- Student MUST sign out at Student Reception prior to leaving the College
- Parents/guardians MUST supervise their child at the trials (do not drop and leave your child, as trials may finish earlier than the scheduled time)
- > Please inform Mr Linning in person or by email if you have been selected in the Pacific District team
